Purpose

The purpose of this policy and procedure is to outline Everest Institute of Education (Ei)’s approach to ensuring it markets and advertises its courses ethically and accurately, in compliance with Chapter 1, Clause 4.1 of the Standards, as well as the Standard 1, 2 and 3 of the National Code of Practice for Registration Authorities and Providers of Education and Training to Overseas Students 2018.

Definitions

CRICOS means Commonwealth Register of Institutions and Courses for Overseas Students.

DET means Department of Education and Training

DHF means Department of Home Affairs

Ei means Everest Institute

ESOS Act means Education Services for Overseas Students Act 2000 of the Commonwealth of Australia.

ESOS Regulations means Education Services for Overseas Students Act 2000 of the Commonwealth of Australia.

Standards means the Standards for Registered Training Organisations (RTOs) 2015 from the VET Quality Framework.

Training Product means AQF qualification, skill set, and unit of competency, accredited short course or module.

VET means Vocational Education & Training

National Code means National Code of Practice for Registration Authorities and Providers of Education and Training to Overseas Students.

Prospective Student means A person who intends to become, or who has taken any steps towards becoming, a Student an 'overseas Student' or 'intending overseas Student' as defined by the ESOS Act.

Policy

1. Everest Institute of Education (Ei) ensures the information provided to students about its services, courses, units and qualifications delivered is accurate and factual, regardless of whether the information is provided by the RTO, its brokers, online directories, agents or other third parties. All information clearly distinguishes between non-recognised training and nationally recognised training.
2. Everest Institute of Education (Ei)'s marketing information will enable informed choice for students by ensuring the information is detailed, accurate and complies with the requirements of the Standards.
3. By complying with the Standards, Everest Institute of Education (Ei) ensures consumer protection laws are adhered to.
4. Everest Institute of Education (Ei)'s advertising is factual and ethical and does not misrepresent Ei's training and assessment, products and other services.
5. All marketing information for nationally recognised training:
 - Identifies Everest Institute of Education (Ei) with its National RTO Code, as well as CRICOS code.
 - Includes the Nationally Recognised Training logo in accordance with its Conditions of Use outlined in Clause 4.1 of the Standards.
 - Includes the full name and code of the relevant Training Product whether it is a unit, module, qualification, skill set or accredited course so there is no confusion for students about the outcome.
 - Be consistent with its training and assessment strategies.
 - Include relevant cost information including all costs, any debts that may be occurred, or any loss of entitlement from the student undertaking the course (such as loss of entitlement for further government funded programs or student loan schemes).
6. Everest Institute of Education (Ei) will not:
 - Guarantee that a student will be issued with a qualification or statement of attainment.
 - Draw false or misleading comparisons with other education providers and courses.
 - Guarantee any employment or migration outcome as a result of training and/or assessment.
 - Guarantee that a student will be automatically accepted into another course.
 - Claim that a student will be eligible for any license or accreditation as a result of training and/or assessment unless it is a license outcome guaranteed by the issuer of the license or accreditation.
 - Give any other false or misleading information or advice in relation to itself, its course or outcomes associated with the course.
 - Knowingly recruit a student before they have completed six months of their principal course of study.
7. Prior to enrolment or the commencement of training, Everest Institute of Education (Ei) provides each individual with current and accurate information that enables the individual to make informed decisions about undertaking training with Ei.
8. Course information provided prior to enrolment will provide the individual with detailed information about fees in line with Clauses 5.1 to 5.3 of the Standards, as well as the National Code 2018 Standard 2.
9. Everest Institute of Education (Ei) will obtain prior written permission from any person or organisation used as a source of comment, testimonial or picture, for any marketing and/or other material and will always abide by the conditions of that permission.

1. Marketing Information

Ensure marketing materials are approved by the CEO/Operations Manager. Keep a register of approved marketing materials on the <i>Marketing Materials Register</i>. <p>B. Monitor marketing information</p> <ul style="list-style-type: none"> Annually review marketing information to ensure it is accurate. <ul style="list-style-type: none"> • Information on course outlines should include: <ul style="list-style-type: none"> – the code, title and currency of the training product to which the student is to be enrolled, as published on the National Register – the training and assessment, and related educational and support services the RTO will provide to the student including the: <ul style="list-style-type: none"> – estimated duration – expected locations at which it will be provided, as well as a general description of facilities, equipment and learning and library resource available to students at each location. – expected modes of delivery – name and contact details of any third party that will provide training and/or assessment, and related educational and support services to the student on the RTO’s behalf, and – any work placement arrangements. – the student’s obligations: <ul style="list-style-type: none"> – any requirements, including visa requirements, that the RTO requires the student to meet to enter and successfully complete their chosen training product, and – any materials and equipment that the student must provide, and – information on the implications for the student of government training entitlements and subsidy arrangements in relation to the delivery of the services (domestic only). • The following is provided in the Student Handbook: <ul style="list-style-type: none"> – the RTO’s obligations to the student, including that the RTO is responsible for the quality of the training and assessment in compliance with these Standards, and for the issuance of the AQF certification documentation. – the student’s rights, including: <ul style="list-style-type: none"> – details of the RTO’s complaints and appeals process required by Chapter 6 • The following is to be provided in the Student Agreement: <ul style="list-style-type: none"> – if the RTO, or a third party delivering training and assessment on its behalf, closes or ceases to deliver any part of the training product that the student is enrolled in

Develop accurate advertising materials</p> <ul style="list-style-type: none"> • Use the <i>Marketing Materials Review Form</i> to ensure that information included is compliant with the Standards for RTOs 2015, as well as the National Code 2018. • Ensure advertising materials are approved by the CEO/Operations Manager • Keep a register of approved advertisements on the <i>Marketing Materials Register</i>. • Advertisements made by third parties must also be approved and recorded on the register. • Keep a copy of all advertising materials. 4. Permissions

Procedure	Responsibility
<p>F. Gain and record permissions for use of testimonials and images</p> <ul style="list-style-type: none"> • If testimonials and/or images or other works of an individual are to be used in marketing material, gain their permission using the <i>Marketing & Media Consent Form</i>. • Record the details of the permission on <i>Marketing Register</i>. • Keep a copy of the signed Permission Form in the relevant student/client file as well as a copy in the marketing folder. • When a client/student’s image or work is used, record this on the permissions register.
